### To the AHMP Awards Committee:

I would like to nominate Mr. Aaron Stern for the Young Hazardous Materials Professional of the Year Award for 2019. I met Aaron for the first time virtually during the January 2019 AHMP Board of Directors (BOD) Meeting in Atlanta. He presented a Business Plan, which I discuss in more detail below, to the BOD that was beyond impressive. I knew right away from his professionalism, his composure, and his passion for the topic that he was going to be an important part of our organization in the future.

During that meeting, the Young Professionals Committee was formed, Aaron was asked to be Chair, and I was asked to be the BOD Liaison for the Committee. Aaron and I have worked together now for 1.5 years and I have gotten to know him very well. I have seen him get excited about AHMP, talk endlessly about new initiatives, and put his all into making things happen for the organization. We have had numerous conference calls, shared hundreds of emails, and even met face-to-face several times despite living miles away. Our goal is the same: increase YPs in AHMP, provide resources and tools they might need, and have fun making these things happen.

Aaron is impressive. If you have met him, you know. He's early into his career, but he's already accomplished a ton. He's not only a CHMM, but he's also an ASP and no doubt one day will become a CSP. He's incredibly well-spoken and very intelligent. Above all, he loves being a hazardous materials professional and truly believes in AHMP.

In determining how to present the Young Hazardous Materials Professional of the Year Award criteria to the Awards Committee, along with providing my own Letter of Recommendation, I decided to combine the two. Below you will see a copy of the first six questions of the Award Criteria listed on the Young Hazardous Materials Professional of the Year Cover Sheet. I took the liberty to provide you with a response to consider as you review and make your selection. In doing so, I provide you with my own personal account and/or refer you to the four additional Letters of Recommendation I received for Aaron on how he qualifies for the Award. At the end, I provide you with my closing thoughts.

1. Is the nominee under the age of 35? RESPONSE: Yes, Aaron was born in the 1980s decade. Refer to https://www.ahmpnet.org/members/?id=55490129.

2. Does the data provided cover the previous calendar year? RESPONSE: Yes, Aaron was first introduced to the AHMP Board of Directors (BOD) during the Atlanta 2019 BOD 1<sup>st</sup> quarter meeting on 19 January 2019 (see Enclosure 1). He was appointed as chair of the newly created Young Professionals Committee during that meeting.

3. Does the data provided demonstrate extraordinary technical, professional, educational, training, and/or administrative contributions to the EHS&S field?

RESPONSE: Aaron's contributions to the EHS&S field are best summed up by his Linked In biography:

"Sustainability-oriented environmental, health, and safety professional with 10+ years of Federal experience.

In my tenure with the U.S. Geological Survey, I have supported the growth of an environmental management program through the development of an Environmental Management System and sustainability initiatives; facilitated a Community of Practice of environmental, health, and safety (EHS) staff; and, designed and hosted a training regime for EHS staff, which includes online training and a 3-day workshop. I am inspired to communicate our progress in sustainability through Tableau data visualizations." Aaron has received his Bachelor of Science from James Madison University in Integrated Science and Technology. He then received his Masters of Natural Resources from Virginia Polytechnic Institute and State University in Environmental Sustainability. While obtaining his Masters he co-authored a case study on Water Resources Management at a Multinational Beverage Manufacturer in Cape Town, South Africa."

4. Does the data provided demonstrate extraordinary technical, professional, educational, training, and/or administrative contributions to the AHMP and/or its chapters? RESPONSE: Yes, Aaron is not only a member of the National Capital Chapter of AHMP, he is an AHMP member in good standing, a member of the AHMP Finance Committee,

often participates in the Conference Committee, and is Chair of the Young Professionals Committee. His contributions are demonstrated through the letters of recommendation from myself, AHMP Chair Mark Bruce (see Enclosure 2), AHMP Vice-Chair Becky Neal (see Enclosure 3), Professional Development Committee Chair Atanu Das (see Enclosure 4), and IHMM Board Member Robin Spencer (see Enclosure 5).

5. Does the data provided demonstrate that the nominee promotes the AHMP Strategic Plan?

RESPONSE: As stated in the AHMP Strategic Plan, the three STRATEGIC BUZZ WORDS are Premier, Sustainable, & Recognized. Aaron embodies each of these.

Premier - Aaron is the YPC Chair. It is a known issue that our AHMP organization is lacking in younger hazardous materials professionals. The BOD had been discussing this issue when Mark Bruce introduced him at the January 2019 AHMP BOD Meeting. Aaron, working with another YP, presented a Business Plan to the Board. They outlined several innovative initiatives they believed to be important in the growth of our organization and to appeal to YPs. They wanted us to look at 1) organizational sustainability - including demographics, trends in associations, target market, and relevance; 2) Strategies - suggested that we should pursue low hanging fruit first, including social media, topic snapshots, and mentorship. 3) Social media implementation - options include website, YouTube, Twitter, and LinkedIn. As part of this, he made a request to obtain a videographer for the 2019 conference in Atlanta; 4) Topic Snapshots - the snapshots would be a way of branding and also a marketing tool; 5) Mentorship Program – they envisioned this would include a survey to match individuals (early career with senior level); and 6) Online Learning Portal - this would be a PowerPoint video repository where individuals could earn certification maintenance points and would include a peer review group to ensure accuracy of information. Based on his enthusiasm, passion, and vision, Aaron was asked to be the Chair of the newly formed YPC.

Sustainable - Since becoming YPC Chair, Aaron has been going full-steam ahead. Besides maintaining his 40+ hour a week professional job with the USGS and pursing his personal hobbies, Aaron has been actively involved in the National Capital Chapter of AHMP for the last two years and his remaining free time has been devoted to the YPC. Of the six initiatives presented at the January 2019 BOD meeting, Aaron accomplished and/or set into motion four of them. He reached out to several video teams/videographers to film portions of the 2019 AHMP Conference in Atlanta, GA, to use as promotional materials and brand recognition for future conferences and membership marketing. He specifically wanted to obtain a set of video episodes and a compilation of those video episodes that can be viewed/distributed on social media. He worked alongside the BOD to budget and select the most valuable, yet economic, candidate. He then worked tirelessly at the conference with the videographer to recruit AHMP members to provide testimonials for the video clips. The final clips produced are a testament to Aaron's hard work at selecting the right videographer and directing him onsite to create two short marketing clips for AHMP. These clips have circulated on social media hitting target markets (hitting initiatives 1, 2, and 3 above). To my knowledge, nothing of this nature has been done before for the organization.

Alongside finding a videographer and determining his logistics for the conference, Aaron worked to achieve the fourth initiative – a topic snapshot. For this task, he worked with a group of AHMP members to collectively create the first topic snapshot for the organization that was presented at the 2019 AHMP Conference in Atlanta. The response was overwhelmingly positive and it all started with his pitch to the BOD less than 8 months earlier.

Recognized – Over the last year, Aaron has made a name for himself within AHMP and for AHMP. In the months leading up to the 2019 AHMP Conference in Atlanta, I asked Aaron if he would be willing to sit on a YP Panel and discuss his thoughts on AHMP, the industry, and how that all relates to YPs. He jumped at the chance and did an amazing job promoting AHMP, the topic snapshots, and the YPC. He truly believes in this organization, which can be seen through his passion, his efforts, and his leadership. At the end of 2019, Aaron shared with me a leadership outline he had been working on. His vision is to eventually have it taught as a one to three day class for YPs on how to become leaders in the hazardous materials professional field and AHMP. He is stepping up to attempt to fill a void that has been missing in the organization – attracting new, younger members. Any AHMP member remotely involved in the organization has seen the name 'Aaron Stern' and knows his commitment to AHMP.

6. Does this nominee meet the minimum requirements for this award? RESPONSE: I believe after you have read this letter, along with the letters of several other leaders within AHMP, your response will be yes.

Aaron Stern is a hardworking, dedicated hazardous material professional, who happens to be young. He has chosen to put his efforts, motivation, and talents into AHMP and making it an organization that is premier, sustainable, and recognized. Aaron is innovative, possesses great communications skills, and shows integrity. I believe he is part of the future success of AHMP as he wants to help AHMP maximize our community, voice, knowledge exchange, and management support of hazardous materials professionals to ultimately make our world safer and healthier. I request you support me in my nomination to make Aaron Stern the 2019 Young Hazardous Materials Professional of the Year and recognize him for all the accomplishments he made or set in motion to promote AHMP. Thank you for your efforts and time!

Recommendations and a timeline were presented. A discussion followed the presentation. Some tasks in the business plan could fall under the YP group.


I've had the privilege of meeting Mr. Stern only once, however, we've had a few personal telephone calls and we've both participated in Conference Planning Committee calls.
