2024 FINANCIAL OVERVIEW

PERFORMANCE

Our successful financial results for 2024 were the fruit of a number of years of hard work both surviving the COVID years and building back. After a series of transitions in our administrative staff, we now believe we've rightsized our administrative expenses to our actual needs.

AHMP began 2024 expecting a budgeted surplus of \$37K. Coming into 2024 we had expected to be able to maintain the administrative cost savings we achieved in 2023. Between cost savings and a successful program year, we ended 2024 with an actual budget surplus of \$134K.

HIGHLIGHTS

- Conference registrations were \$170K, up slightly from both 2023 actual and 2024 budget
- Our conference exhibitors and sponsors were finally back to roughly pre-COVID levels, contributing more than \$116K, moving the conference from a bare break-even to a significant revenue generator.
- We had a very successful set of Essentials of Hazardous Materials Management courses at both the National and Chapter levels, contributing \$38K to our bottom line.
- Non-conference expenses came in \$10K below budget.
- Conference expenses were \$24K above budget due primarily to the increased size of the conference.

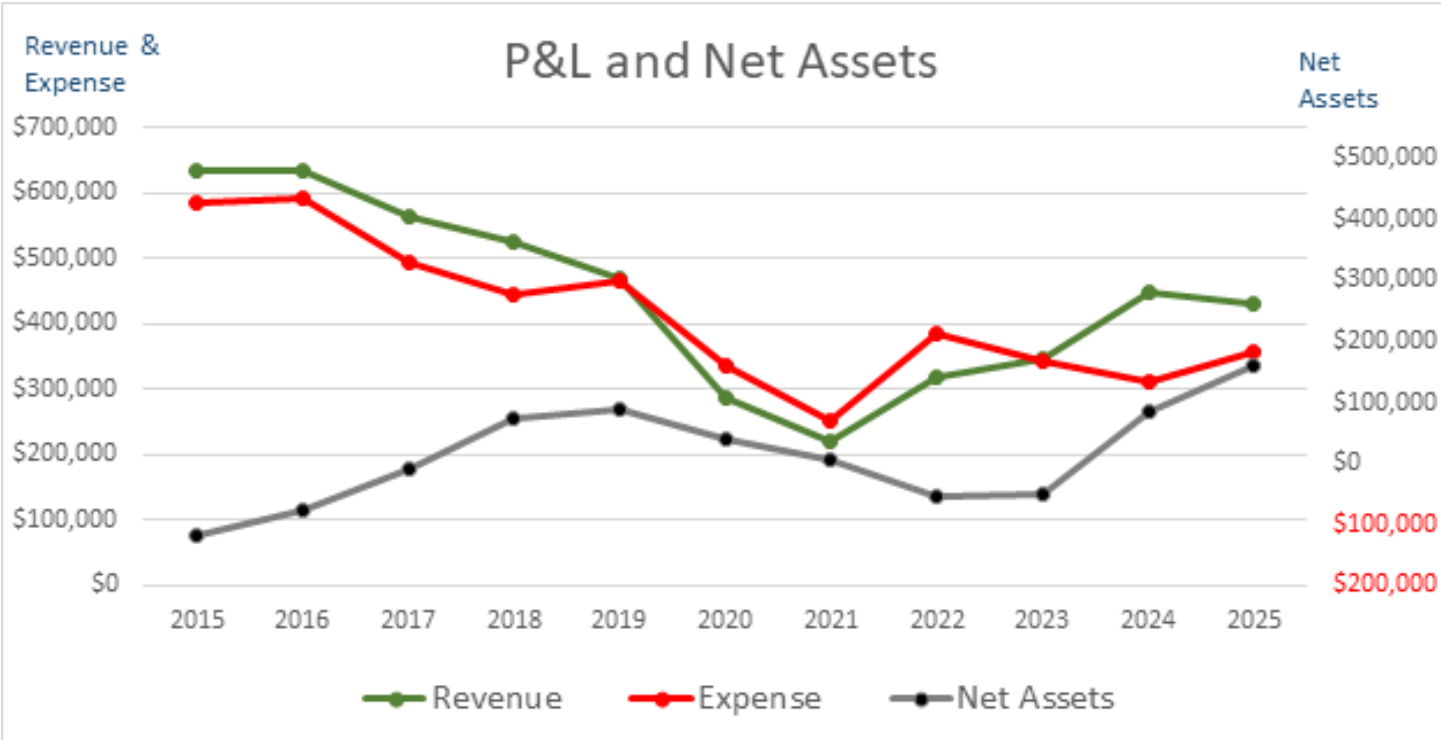
2025 BUDGET

The approved 2025 budget projects a net income of \$72,975. We are also looking to return some of what might have been surplus to increased member benefits, including funding for the conference keynote speaker that allowed us to attract Robert Bilott!

The chart below illustrates the past 10 years of AHMP profit and loss. By close of 2025 we expect AHMP to be fully out of the financial hole caused by COVID and in a better cash position than we've had since 2008. As our finances improve, it's the Board's intent to begin reinvesting much of our surplus into additional member services.

HIGHLIGHTS

- While we believe we likely can achieve continued growth in revenue, we are conservatively budgeting revenue to remain flat and hoping to surprise ourselves by year-end.
- We're putting a little more funding into the conference budget to enhance the attendee experience.
- We've put aside a small marketing budget for the production of a membership brochure for use both by National and by chapters and sections.
- Administrative costs are budgeted slightly above 2024 actuals because we don't expect the gaps in staffing that we experienced last year.

EMERGENCY RESPONSE SCENARIO

The ERS demonstrated how emergency crews respond to a tanker car accident with a real rail car and a simulated release. Attendees were walked through initial response and threat assessment by the local fire and hazmat teams, coordination between the railroad, emergency responders and hazmat contractors, and saw demonstrations of some of the emergency equipment that might be used to contain and control such a release.

EHMM COURSE

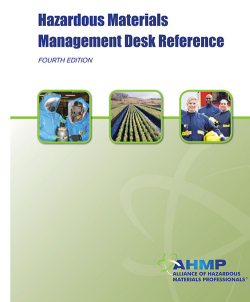

EHMM SCHOLARSHIP

EHMM Scholarships for course tuition are awarded once per calendar quarter. In order to apply for the Scholarship, please submit a letter responding to the below enumerated criteria. Scholarships will be issued only to members in good standing of AHMP, an AHMP-affiliated chapter (including CyberChapter), or an AHMP-affiliated section. EHMM Scholarships for tuition can be used for virtual or in-person events. The scholarship will cover the tuition and an e-Desk Reference at the price offered by the entity providing the EHMM course (there is some variation among providers). Two scholarships were awarded during 2024.
